Update on Cherokee/Hugue not Traffic Light

The follow letter was sent to the neighborhood groups in the Southampton/Cherokee road areas:

I am writing to update you on the proposed full traffic signal at the intersection of Huguenot and Cherokee Roads. More than a year ago, on August 19, 2019, I hosted a meeting at the Huguenot Community Center to discuss the Department of Public Works' (DPW) proposal for the signal. Travis Bridewell, the City's Traffic Engineering Operations Manager, presented the proposal along with crash data justifying DPW's support of the project.

Between 2015 and 2018, there were 26 vehicle crashes at the Huguenot and Cherokee intersection. Since that meeting, our office has heard from many of you with safety concerns from drivers and bicyclists who pass through this well-trafficked area.

I realize that there are a number of residents who are concerned that the installation of a full traffic signal at this intersection might increase traffic volume and speeds along Cherokee Road. Fortunately, DPW will be [installing 2 speed tables on Cherokee Road this spring](#) which will help to slow and deter traffic. This was an option that was discussed at the meeting in 2019.

Based on the traffic crash data and the community feedback I have received over the past year, I am in full support of the Huguenot/Cherokee full traffic signal which will include ADA ramps, pedestrian countdown signals, and ladder crosswalks. The project is not currently funded, but I have expressed my support for it in forthcoming budgets.
